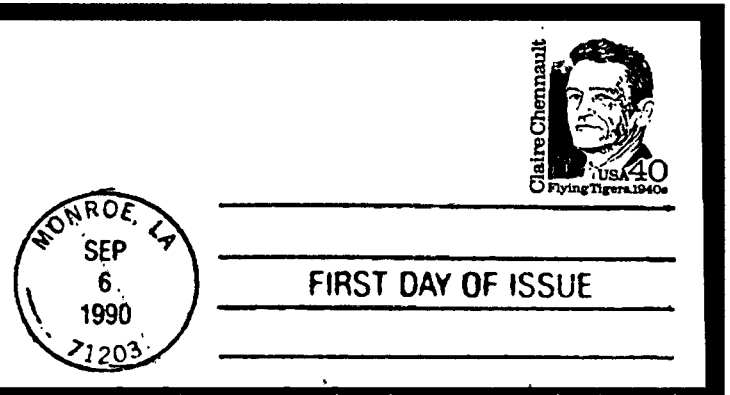
General Chennault of the Flying Tigers Honored

The First Day of Issue ceremony for the 40-cent U. S. definitive stamp honoring General Claire Lee Chennault was held September 6th at 9 A.M. on the campus of Northeast Louisiana University at the Anna Gray Noe Alumni Center, in Monroe, Louisiana. The Great American Series stamp was designed by Christopher Calle of Stamford, Connecticut, and features a bust of Chennault based on a circa-1944 photograph. The date of issue was the 100th anniversary of Chennault's birth. About 3,000 people attended the unveiling, including many dignitaries, family members, World War II veterans and members of the Flying Tigers and representatives from Taiwan. (A similar stamp honoring General Chennault is planned by the Taiwanese post office, to be issued September 26th.) Chennault's widow, Anna Chennault, and some of the original members of the Flying Tigers autographed First Day Covers following the ceremony. The ceremony was highlighted by a military fly-by of the Confederate Air Force from Harlingen, Texas. The postal service sold Chennault souvenir mugs, T-shirts and caps before and after the ceremonies.

General Chennault was given this honor on the recommendation of thousands of veterans who wrote to the U.S. Postal Service. The Flying Tigers of the 14th Air Force Association had been trying to get a stamp honoring Chennault for thirty years. They indicated that he was a brilliant military tactician, a true pioneer in that field and a great officer....as one former Flying Tiger said during a television interview..."way ahead of his time." Family members and local people from the Monroe area wrote to postal officials and President Bush in the effort to have the ceremonies held here where he lived for many years, instead of New Orleans as originally planned.

Chennault was born on September 6, 1890, in Com-



merce, Texas, where his father was temporarily employed. When the job ended six months later, the Chennault family returned to Louisiana. Chennault's mother died when he was very young and he became somewhat of a loner. In his book, *Way of a Fighter*, Chennault wrote, "My earliest recollections are of roaming the woods and swamps. Life in these woods and on the bayous and lakes taught me self-confidence and reliance and forced me to make my own decisions."

Chennault attended Louisiana State University for three years, then transferred to Louisiana State Normal School (presently Northwestern State University) earning a teacher's certificate. That same year he met Nell Thompson in Winnsboro, Louisiana; they courted for a year and were married in 1911 on Christmas Eve.

Chennault earned his flying wings while serving in the US Army during World War I. Following World War I, Chennault became a member of the US Army Air Services. During his tour with this branch, he became an expert precision flyer. Over the years, Chennault and his family moved to numerous Army Air bases. While stationed in Hawaii in 1923, Chennault initiated new plans and tactics for military aircraft. He described the fighter techniques being taught at the time as "medieval jousting in dogfights."

Chennault's opinion that the next war would be an

Hints, Tips, & Other Brainstorms:

Re: Stamp Hinges - I have tried the C/D Hinges (which I suspect maybe the German brand you are referring to.) My first packet, purchased about 18 months ago, seemed to work very well. I usually am careful to use very little moisture, however. Last time I sued them I noticed that with more moisture they were less satisfactory, i.e. about the same as regular hinges. I also cut my hinges in half, making two hinges out of one, which I find works well for all used and most mint stamps and minimizes any negative peeling affects. I must say, however, that I have not

In any case, I too am interested in obtaining better hinges, like the ones sold 30 years ago. On the one hand I can't believe that the ultra-fussy German collectors settle for prolematic hinges, but then again they are so fussy they may not use hinges at all! I know of one English dealer who tells his new philatelists flatly not to use hinges, period. Please let me know if you find an answer. I'll do the same.

Responding to my previous remarks about poorer results from USA and better results from packets, there is a relative paucity of US material and a large increase in packets. I probably should avoid such remarks in the future, as my aim is to encourage submission of a broad pan-philatelic pot-pourri. RAECH'S RUMINATIONS

This is being written in mid-summer and my tomatoes and cucumbers are doing quite well, thank you. My stamp collection is doing just as well, if not better. Strange, but my enthusiasm has not waned as it usually does during the summer. In fact, it's moving into high gear.

For years, I've been hinging new additions onto blank pages (my albums stop at 1972). It's a pain in the whatever checking to see whether or not I've got a stamp after soaking, drying and sorting a batch or two. At least I was smart enough to identify each mounted stamp with its Scott catalog number. I am now rearranging the mess and remounting in Scott order. I thought I had a lot of stuff, but it seems I'm missing a lot more. The problem now is to find what's missing and fill up those empty spaces.

Basically, I get my stamps from commemorative mixtures, trading partners (fellow ISWSC members) and two "formal" exchanges. Buying commemorative mixtures generally excludes definitives and the higher value commemoratives. Buying definitive mixture would most likely result in getting a bunch of low values (many of one kind) and a few of the higher values. It seems I'm caught between a rock and a hard place. My trading partners and the exchanges have been very helpful in plugging the holes but there's still many more to fill. As our editor pointed out last issue, dealers are mainly into mint original gum and don't see any profit in "cheap" stamps. Maybe it's up to us to fill our own gaps.

How about some sort of round robin swap system? Let's say a group of us (5-8-10 or whatever) got together. I'd send 50 stamps to # 1 on the list. He'd take out what he needed, add 50 of his and pass them all on to # 2, etc. When the bunch of stuff finally got back to me, I'd take out what I needed and those I originally placed in the circuit (if I could find them), put back the number I took out, and start the circuit going again or the remainder could be donated to our auction. I know there's no guarantee that I'd find what I was looking for, but I bet I'd fill a good many gaps. Possibly, a certain group of countries could be rotated and different group of countries substituted for the next go around. Sound feasible? Let me hear from you. S'all for this time.
